- To use EMB153 for pallet label.
- The correct pallet V8 Art.No 2075027 (No other pallet is allowed to use!)
- Always fill up with a full layer of boxes to make a complete layer. If necessary fill up with empty boxes.
- Maximum layers of boxes are 4 on each pallet.
- Use top lid and two straps as shown in the instruction.
- Do not use strech film, use 2 straps on the longside only.






